Boat operations can be dangerous, particularly entering or exiting a boat. Other hazards include drowning, serious injuries from slips and falls, or collisions from other boats. Weather can also cause hazardous conditions.

AGREEMENT, WAIVER, AND RELEASE

In consideration for being permitted by the above district to participate in the above activity:

I hereby acknowledge, understand and agree to defend, indemnify, save and hold free and harmless Helix Water District ("District"), its Board, members of the Board, employees, and authorized volunteers (collectively, "Releasees") from any and all liability from loss, damage, cost or injury, including wrongful death, to any property or persons, including third parties, in any manner arising out of or incident to any of my acts, omissions or willful misconduct while participating in said activity, whether or not due to the negligence of the Releasees. Further, I shall defend at my own expense, including attorneys' fees, the Releasees in any action or proceeding, legal, administrative or otherwise, based upon such acts, omissions or willful misconduct.

I hereby acknowledge, understand and agree to: (1) to assume all risks inherent in the activities which are available and in which I may participate, and understand that these activities involve risk to my person and property, and (2) to assume the risks, if any, arising from the conditions and use of equipment and facilities. Within the scope of this release is any cause of action, arising from the performance of, the failure to perform maintenance, inspection, supervision or control of equipment and facilities, or the failure to warn of existing dangerous conditions not known to or reasonably discovered by the District, including all acts of negligence of the District.

I hereby acknowledge, understand and agree, in consideration for being allowed to participate in the Event, that I, my personal representatives, heirs, next-of-kin and assigns (collectively, the "Releasers") hereby release, waive, discharge and covenant not to sue the Releasees from and for any and all liability for any loss or damage to me or the other Releasers, and from and for any claim or demands therefor on account of injury to the person or property of me, including death.
