Spaces for sellers will be marked and are available on a first-come, first served basis. Spaces will be approximately 12x12. You will need to supply your own tables, chairs, and canopies.

The event space will open for set-up at 6:00 AM. To maintain a consistent experience for buyers, sellers must remain for the duration of the event. No vehicles will be allowed to remain in the event space during the swap meet, 8:00 AM to 12:00 PM.

Types of Items Allowed

- **Fishing Gear** including rods, reels, fishing line, hooks, lures, tackle boxes, and other fishing accessories.
- **Fishing Apparel and Tools** like fishing vests, boots, gloves, coolers, fish finders, etc.
- **Used Items:** If selling used fishing gear, make sure all items are in good working condition.
- **Prohibited Products:** Items like weapons, drugs, counterfeit goods, and hazardous materials are prohibited. No live bait is allowed.

Please carefully read the rules and regulations. All sellers must agree to and sign the waiver of liability in order to participate in the swap meet.

Behavioral Conduct and Customer Interactions

- Sellers should engage with customers in a friendly, professional manner. Aggressive sales tactics or disruptive behavior is prohibited.
- If you're able to demonstrate fishing gear, make sure to do so safely and ensure that all equipment works as expected.
- Be prepared to handle customer complaints or returns. Make sure to clarify your return policy with buyers in advance.
- Lake Jennings is not responsible for mediating disputes or disagreements.

Booth and Display Regulations

- Sellers are required to supply your own tables, chairs, or canopies.
- Sellers are required to set up within the designated booth space provided.
- Sellers are allowed to display signage, but it should not be excessive or obstruct the view of other booths.
- Sellers are required to keep their booth area and the area directly in front of their booth clean.
- When leaving, your space **MUST** be clean and in the same condition as when you arrived. Trash, boxes, or other debris may not be left on the grounds. Any unsold items must be taken with you.

Set-up and Takedown Rules

- **Arrive On Time:** Set-up begins at 6:00 AM and ends at 7:45 AM. It's important to arrive early to get your booth ready before the event starts. No vehicles will be permitted in the event area between 7:30 AM and 12:00 PM.
- **Stay Until the End:** Leaving early is not allowed. Sellers should remain in their booth for the entire event FROM 8:00 AM to 12:00 PM. This ensures a consistent experience for shoppers.

Lake Jennings assumes no responsibility for the property of the seller from fire, theft, malicious mischief, accident, or other cause. The seller is responsible for protecting their property at all times during the event.

Cash and Payment Methods: Cash, credit, exchange, or alternative forms of payment e.g. Venmo or PayPal are permitted. Sellers should ensure they have the tools to process these payments.

Noise Levels: Sellers should keep noise levels to a reasonable level to avoid disturbing other sellers and shoppers. No amplified music or the use of a microphone is permitted.

For the safety and comfort of all guests, **dogs are not permitted** at the swap meet. Service animals are welcome in accordance with ADA guidelines.

Tax Compliance: Sellers are responsible for ensuring they collect and remit the correct amount of sales tax to the proper authorities, based on the location of the swap meet.

Lake Jennings retains the right to restrict, exclude, or evict sellers or exhibits, because of their method of operation, noise, or that which may detract from the general character of the event. This includes persons, things, printed matter, or anything else judged to be objectionable.

VOLUNTARY RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of being permitted to enter upon and access Helix Water District's Lake Jennings facilities for any purpose including, but not limited to, observation, use of any facilities or equipment, or participation, in any way, the undersigned hereby acknowledges, agrees and represents that he/she has inspected, or immediately upon entering will inspect such premises and facilities. At the time of reservation, the District shall disclose to the undersigned any safety issues and/or defects of the facility or equipment which the District is aware of. It is further warranted that such entry in Helix Water District's Lake Jennings facilities for observation, participation, or use of any facilities or equipment constitutes an acknowledgement that such premises and all facilities or equipment thereon have been inspected and that, to the best of the undersigned's knowledge, the facilities or equipment are reasonably suited for the purpose of such observation or use.

In further consideration of being permitted to enter upon and access Helix Water District's Lake Jennings facilities for any purpose including, but not limited to, observation, use of facilities or equipment, or participation, in any way, the undersigned hereby agrees to the following:

The undersigned hereby releases, waives, discharges and covenants not to sue Helix Water District, its Board, members of the Board, employees, agents, or authorized volunteers (hereinafter referred to as "Releasees") for any and all liability for any loss or damage to the undersigned, and any claim or demands therefore on account of injury to the person or property or resulting death of the undersigned, or for any loss or damage, and any claim or demands therefore on account of injury to person or property or resulting death of persons attending an event for which undersigned is the approved applicant, including but not limited to the undersigned's guests, invitees, vendors, agents, and contractors, except if and to the extent caused by the negligence or willful misconduct of the Releasees.

The undersigned hereby agrees to defend, indemnify and save and hold free and harmless the Releasees and each of them from any and all loss, damage, liability, cost or injury they may incur which is caused by the undersigned, or persons authorized by the undersigned to attend an event for which undersigned is the approved applicant, including, but not limited to, the undersigned's guests, invitees, vendors, agents, and contractors, except if and to the extent caused by the negligence or willful misconduct of the Releasees.

To the best of the undersigned's knowledge, the undersigned hereby certifies that he or she is fully aware of the risks and hazards inherent in entering upon and accessing Helix Water District's Lake Jennings facilities and agrees to accept and assume full responsibility for any and all risk of bodily injury, death or property damage due to the acts, omissions, or negligence of the undersigned while in, about or upon Helix Water District Lake Jennings facilities and/or while using the premises or any facilities or equipment thereon, and assumes full responsibility for and risk of bodily injury, death or property damage to persons authorized by the undersigned to attend an event for which undersigned is the approved applicant, including, but not limited to, the undersigned's guests, invitees, vendors, agents, and contractors. The undersigned further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned has read and voluntarily signs this release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made. In signing this Agreement, the undersigned expressly waives all rights which it may have under California Civil Code section 1542 which provides:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

Thus, notwithstanding the provisions of Section 1542, and for the purpose of implementing a full and complete release, the undersigned expressly acknowledges that this release is intended to include in its effect, without limitation, all claims, known or unknown.

I HAVE CAREFULLY READ AND UNDERSTAND, ACKNOWLEDGE AND AGREE TO THIS RELEASE. I UNDERSTAND THAT I MAY SEEK THE ADVICE OF AN ATTORNEY IN ANY MATTER CONNECTED WITH THIS RELEASE BEFORE SIGNING AND HAVE AGREED TO SIGN THIS RELEASE OF MY OWN FREE WILL.
